

# National Health Insurance Enrollment Eligibility for Foreign Professionals and Their Dependents

The latest amendment of The Act for the Recruitment and Employment of Foreign Professionals was set to be effective since Oct. 25, 2021

## 一、Enrollment eligibility and How to apply for Enrollment :

Employed foreign professionals	<ul style="list-style-type: none"> <li>◆ Their companies(employers) have to apply the enrollment for them from <u>the date when they are hired.</u></li> <li>◆ Their employers have to enclosed the following documents for reference:                             <ol style="list-style-type: none"> <li>1.Their work permits.</li> <li>2.Their Alien Resident Certificates (ARCs).</li> </ol> </li> </ul>	<ul style="list-style-type: none"> <li>◆ Their spouses, minor and disable adult children having obtained documentary proof of residence, have to participate in National Health Insurance.</li> <li>◆ The professionals' employers have to enclosed Alien Resident Certificates (ARCs) of the dependents for reference.</li> </ul>
Foreign special professionals & foreign senior professionals who are employers or self-employed business owners	<ul style="list-style-type: none"> <li>◆ They have to apply as a group insurance applicant through our branch office, complete the enrollment for themselves from <u>the date their business is founded.</u></li> <li>◆ The Group insurance applicants have to enclosed documents as follows for reference:                             <ol style="list-style-type: none"> <li>1. Their Employment Gold cards.</li> <li>2. Their Alien Resident Certificates (ARCs).</li> </ol> </li> </ul>	<ul style="list-style-type: none"> <li>◆ Their spouses, minor and disable adult children having obtained documentary proof of residence, have to participate in National Health Insurance.</li> <li>◆ The Group insurance applicants have to enclosed Alien Resident Certificates (ARCs) of the dependents for reference.</li> </ul>
Foreign professionals who are not in employment, those foreign special professionals & senior professionals who are not employers or self-employed business owners	<ul style="list-style-type: none"> <li>◆ Those who holding an Alien Resident Certificate (ARC) and staying in Taiwan <u>for six full months</u> must join the NHI program.</li> <li>◆ They have to bring their alien residence certificates to complete the enrollment through the local township, county-level city, or district office.</li> </ul>	<ul style="list-style-type: none"> <li>◆ Their spouse, minor and disable adult children having obtained documentary proof of residence, have to participate in National Health Insurance while continuously staying in Taiwan <u>for six months.</u></li> <li>◆ From December 1, 2017, a foreign newborn who was given birth in Taiwan and with an Alien Resident Certificate (ARC), should be enrolled in the National Health Insurance program since <u>the date of birth.</u></li> </ul>

To apply for a NHI IC Card	Please fill out the NHI IC Card Application Form, along with a photocopy of your Alien Resident Certificate (ARC), one 2-inch personal photograph, through your group insurance applicant to apply for your NHI IC Card then receive our medical coverage.
